The goat meat market is strong in the United States. Over half of the goat meat eaten here is imported because producers cannot keep up with demand. The dairy products market has been expanding along with cottage industries such as the goat milk soap and related products being sold directly to consumers.

Unfortunately, high production costs can deter producers from getting into commercial meat goat production, and the dairy goat milk industry is facing regulatory restrictions that affect the ability to market milk. The show goat industry is stable, but many of the breeding and show stock goats being sold are in essence merely changing hands from one U.S producer to another because producers are constrained when it comes to international markets. AGF is working to address these issues for American producers.

#### FDA Seeks Comments on Combination Drugs

The FDA is considering changing the approval process for drugs used in combination in medicated feeds. Currently, the use of combined drugs in a medicated feed requires an approved new animal drug application (NADA) for each drug individually, and a separate NADA for the combination. The FDA says it is exploring changes to allow combination drug medicated feeds available in an efficient manner while protecting public health. *By John Maday, Drovers CattleNetwork, 08/24/15*

thought, new NASA satellite imagery shows. Some areas of the Golden State are sinking more than 2 inches per month, the imagery reveals. Though the sinking, called subsidence, has long been a problem in California, the rate is accelerating because the state's extreme drought is fueling voracious groundwater pumping.

What's more, this furious groundwater pumping could have long-term consequences. If the land shrinks too much, and for too long, it can permanently lose its ability to store groundwater, the researchers said. The state's sinking isn't new: California has long suffered from subsidence, and some parts are now a few dozen feet lower than they were in 1925, according to the U.S. Geological Survey. But the state's worst drought on record - 97 percent of the state is facing moderate to exceptional drought - has only accelerated the trend. *By Tia Ghose, Fox News, 08/24/15* 

What You Should Know About the EPA WOTUS Rule
If you think that because you are small this rule doesn't
affect you, don't be so sure. Fines can be \$37,000 per
incident, per day, per violation!

Right now this regulation applies if you have an unauthorized discharge of "pollutants" from your farmland that requires a Clean Water Act (CWA) permit. It's all part of the new rule recently issued by the EPA and the Army Corps of Engineers defining waters of the U.S. (WOTUS). It expands the federal CWA jurisdiction over many landscape features found on farm, ranch and forest lands across the nation.
