

AGF Representatives shared goat industry needs and concerns at the USDA Sheep & Goat Sector meetings in Washington DC on March 30.

Tom Boyer and Bob Buchholz attended in person, and Dr. Ken Andries, Lary Duncan and Anita Dahnke attended via phone. **APHIS Administrator** Kevin Shea gave an overview of program initiatives, and progress on items from previous sector meetings. Jack Shear, Veterinary Services Deputy Administrator and Bill Clay, Wildlife Services Deputy Administrator also provided information to attendees. In addition, the sector meeting provides the opportunity for attendees to give input to Administrator Kevin Shea about industry needs and priorities.

Bob Buchholz, AGF Director, ASI Director and AGF representative on the Executive Board of the American Sheep Industry Association participated in the first of the House Agriculture Livestock Subcommitte's farm bill hearings for ASI on March 21.

While he presented sheep industry priorities for the farm bill, the presentation also hit on priorities for the goat industry, including risk management tools, andfunding for a foot and mouth disease vaccine bank,

### American Goat Federation 2017 Annual Producers Seminar

Topics covered during the Seminar included:

**Sore Mouth in Goats:** Dr. John Walker, professor and research director at Texas A&M Agricultural Research and Extension Center shared information about the different strains of this problem that can affect all small ruminants.

**Update on Scrapie Eradication Program**: Dr. Diane Sutton, National Scrapie Program Coordinator provided information about the current state of the Scrapie Program in the US and the progress that has been made in identifying the actual presence of Scrapie in sheep and goats.

Genetics of Scrapie in Goats: Dr. Stephen White, Research Geneticist at USDA-ARS Animal Disease Research in Pullman, Washington provided information about the 10 year study they've conducted on Scrapie in goats and identification of genetic markers that show resistance to the disease.

American Dairy Association Genetics Performance Programs: Elizabeth Henning, AGF Director, and member and past chair of the ADGA Genetic Advancement Committee, provided information about the ADGA program and how it has helped improve the quality of dairy goats and milk production.

**Health Concerns in Goats:** Dr. Joan Bowen, practicing veterinarian in Colorado and past president of the American Association of Small Ruminant Practitioners provided information on common problems in goats and proper management practices for preventing disease and other issues.

Genetics, Genomics and the Future of Goat Production: Dr. Noelle Cockett, President of Utah State University and former research geneticist at the ARS Research Center in Nebraska shared basic information about how genetics work and what is being done with genetics to benefit the goat industry.

Q Fever, Challenges and Opportunities: Dr. Stephen White with genetics to benefit the goat industry gave an overview of Q Fever and the research that has been done to date to identify ways to control this disease that can

### USDA Makes it Easier to Transfer Land to the Next Generation of Farmers and Ranchers

Agriculture Deputy Under Secretary Lanon Baccam announced in December that beginning January 9, 2017 the USDA would begin offering early termination opportunity for certain CRP contracts, making it easier to transfer property to the next generation of farmers and ranchers, including family members. Eligible land for the early termination is among the least environmentally sensitive land enrolled in CRP.

#### The Quirks of Working with Goats and Sheep

Dr. Duemler of Brodhead Veterinary Clinic in Wisconsin is one of many veterinarians across the country who spend time working with small ruminants, particularly goats and sheep. Goats live on about 128,000 farms in the U.S. according to the 2012 Census of Agriculture with a population of about 2.6 million. Sheep are on fewer farms, 88,000, but are more numerous with a population of about 5.4 million.
